





We have strategically invested for oil depot terminal in Thilawa, Thanlyin to meet with the highly competitive future market demand. This project initiated and received approval from MIC in FY 2012-2013. Total storage capacity of phase one and phase two is 96,410 MT for 10 tanks. After completion of phase one and phase two and according to the market demand, our future plan is to expand to 18 tanks with 113,600 MT capacity.




TOTAL WORK FORCE BY GENDER




